February 2011

The 2011 Joint Dinner was held on Thursday, January 20th at the Terra Cotta in Binghamton. 152 guests enjoyed dinner and **VOLUME XXXIII** No. 3



an outstanding presentation by Dr. Kate Foster of SUNY Buffalo on the topic of consolidation. Dr. Foster is the Director of the University of Buffalo Regional Institute and her area of expertise includes regions, governance and regional decisionmaking. Her talk "School District Reorganization 2011: Contemplating

the Urge to Merge" considered the unusual alignment of political, economic, legal and social forces now prompting a resurgence of interest and activity in major reorganization of school districts and local government. Once focused on service sharing or other non-structural collaborations, area leaders contemplate and respond to proposals for consolidation, dissolution, downsizing, and other major reforms with profound implications for governance, finance and service delivery. This illustrated presentation reviewed the environment for change, outlined the amount, types, pros, cons and tradeoffs of reorganization activity and contemplated the prospects for more change in 2011 and beyond.

Dr. Foster presented a similar speech on Friday morning, January 21st for the Greater Broome Chamber of Commerce Legislative Committee and guests. It was very well received and prompted discussion and a better understanding by Chamber members on the issues school districts face when contemplating merges and/or consolidations. This topic was very timely with the State budget deliberations proceeding this winter.

2011 Legislative Breakfast

The Legislative Breakfast was held Friday, February 4th on the Broome-Tioga BO-CES campus in the student cafeteria of the Les Distin Education Center. 65 super-intendents, board members and school officials along with Senator Tom Libous, Assemblyman Cliff Crouch, Assemblywoman Donna Lupardo, Assemblyman Chris Friend and Debbie Howard from Assemblyman Gary D. Finch's office gathered together to discuss some very serious education issues that our districts are facing.

Randy Kerr, SBA Legislative Committee Chair and Newark Valley Central Schools Board of Education President, spoke on the current retirement system and how it needs to be controlled; Dave Hawley, Binghamton City Schools Board of Education President spoke on the proposed 2% tax cap and how it will negatively affect our districts; and Dr. Bill Russell, Superintendent of Schools, Owego-Apalachin Central Schools spoke on school budgets and what goes into crafting a plan that supports our children and that taxpayers can support.

Local legislators then stepped up to the microphone to give an idea of how education issues are being discussed in Albany. The picture they painted is bleak. While being careful not to give false hope, they all promised to fight hard to find ways to help ease the cuts in aid that our new governor is projecting. Each agreed that legislation to pass a resolution on mandate relief is key and urged everyone to visit Governor Cuomo's website and post ideas and opinions on additional ways to help curb costs. Other topics visited during their time at the podium included a state-wide health insurance system and the importance of an on-time budget. Jason Andrews, Superintendent of Schools, Windsor Central Schools, noted that there are many projected cuts to BOCES services in the new state budget and that this seems to be in direct contrast with the consensus for schools to find ways to share costs. Local legislators were unaware of all the BOCES programs that are earmarked to be cut and asked that this list be forwarded to them for review.

A very special thank you goes to Broome-Tioga BOCES Education Center for all of their assistance with this event. Students from the Culinary Arts, Skills USA, and the Criminal Justice Departments helped with food service, hosting and parking during the morning event. Breakfast was provided by the Culinary Department, table centerpieces by the Floral Arts Department and entertainment by the Knee High Chorus.
