BOCES (Board of Cooperative Educational Services)

is a unique and innovative educational institution established to provide equitable learning opportunities to students in all public school districts and help those schools control costs by sharing services. It functions as an extension of the local school districts and the state education department.

New York is divided into 37 BOCES regions. Public schools within each region decide whether, and to what extent they want to participate in their BOCES. All BOCES are subject to the regulations and guidelines of the state education department, but each is unique due to the varied geographic and demographic needs of its participating schools.

All BOCES operate under the guiding principles of cooperation, coordination, interdependence and shared decision making. Their primary role is to provide services to their clients, the local school districts. These services vary from direct instructional programs in career, alternative, and special education, to providing instructional resources, technical services, staff development, and management systems.

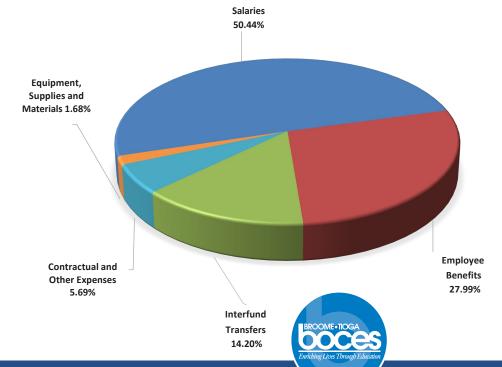

Instructional Programs







BOCES Instructional Programs strives to provide every student with the knowledge, skill, and

confidence necessary to succeed in college or the workplace. Aligned with our mission— to educate, empower and inspire individuals to realize their full potential and pursue lifelong success - our emphasis is on broad educational programming with sustained support built on a foundation of enduring partnerships. Our programs provide students of all ages with training and services in special, alternative, career, and adult education in partnership with our component school districts, local employers, and agencies throughout the community. Through rigorous academics, career-building opportunities, and a commitment to maximizing potential and planning futures, we strive to lay the groundwork for every student to attain the knowledge, skills and confidence necessary to empower and inspire them to realize their potential as they pursue lifelong success.

Adult Education provides literacy programs that include English for speakers of other languages (ESOL), TASC instruction, and job training courses in a wide range of professions. In addition, our Customized Employer Training program targets the unique workplace needs of area businesses and organizations.

Alternative Education programs provide New York state regents diploma-based education for students in grades K - 12. We have alternative classes in several geographically convenient locations around the region at the elementary, middle and high school levels. Our P-TECH program each year gives a select group of ninth-graders the chance to earn a free associate degree through high school curriculum, focused STEM education and hands-on learning opportunities.

Career & Technical Education offers training opportunities at both the exploratory and commencement level in a variety of areas, including automotive, building trades, health careers, human services, computer services, engineering technologies and culinary arts. Our New Visions program offers motivated seniors real-world instruction and hands-on career experiences

through academies specializing in business, education, engineering, health, and law & government. Our Tech Academy serves students in grades 9 and 10 in an interdisciplinary technical environment.

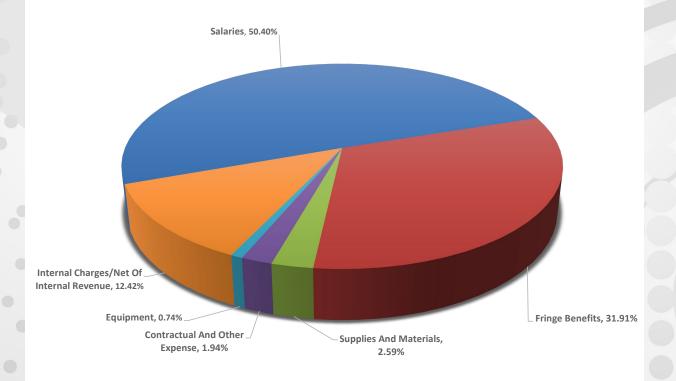
Extended Education programs address a range of student needs, including a Regional Cooperative Summer School to help students meet state graduation requirements, extended-year special education programs to reinforce prior year coursework, district-based enrichment programs (after school and summer sessions), Odyssey of the Mind competition, and other specialized opportunities. Additionally, districts may collaborate to develop enrichment programs to enhance academic success.

Special Education provides a continuum of services for students with disabilities from age 5 through 21. Offerings range from diploma-based programs to programs for students taking the NYS alternate assessment. BOCES also offers a variety of related services such as occupational therapy, physical therapy and speech. Increasing student independence and maximizing their potential are the

cornerstones of our programming.

The Center For Educational Support & Technology provides leadership and cost-effective programs and services to schools in Broome-Tioga BOCES, DCMO BOCES and ONC BOCES.

Our many programs and services are administered under two categories: the Professional Learning and Innovation Center and the Regional Information Center. The first provides a range of professional learning opportunities and resources to advance curriculum, instruction and assessment for schools. The latter provides state-of-the-art technology and data services on which schools depend for such daily operations as financial management and student reporting. Together, they ensure BOCES' commitment to supporting districts in their efforts to improve teaching and learning.

Professional Learning and Innovation Center includes programs in the areas of curriculum, instruction, integration of technology and assessment. Professional learning is provided to teachers and

administrators in regional workshops and through customized on-site training and support.

Resources include a broad range of instructional software, digital content, video conferences, course management systems, and library services. The media library provides instructional resources for teachers, including digital streaming media, multi-media kits, and multiple copy books. Other instructional resources include Arts in Education and Extended Classroom opportunities for students. Additionally, educators can use a mobile planetarium or borrow physical educationequipment. Professional learning opportunities on the effective use of the resources are included as part of the services.

Regional Information Center

provides information technology services for the 50 school districts of B-T BOCES, ONC BOCES, and DCMO BOCES. Information technology services include

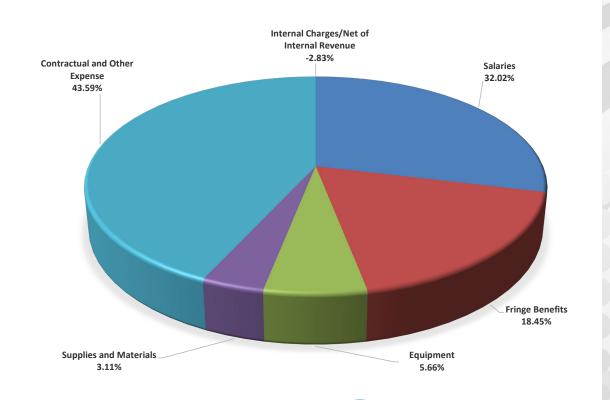
operations and infrastructure, purchasing of hardware and software, support of applications, strengthening data security and privacy, and technology leadership.

Technology Infrastructure Services

include the support of a network operations center, backup and disaster recovery services for districts, engineering and support of the districts' LAN and WAN. Services include Managed IT, Network Support, and hardware/software purchasing.

Data & Applications Services include educational data reporting support, data integration, custom reporting, staff training and application support. Services include managed data, data integration, custom reporting, student management systems, financial services, special education services, cafeteria services and administrative services (auto notification, board meeting management, building automation, electronic document management, facilities management, professional development, and web

Management Support Services







Management Support Services enable districts to share personnel and expertise in a variety of administrative functions.

Central Business Office provides centralized services, including payroll, accounting, accounts payable, purchasing, claims auditing, Affordable Care Act reporting, and budget/financial analysis in a professional business model with shared management and support staff.

Cooperative Purchasing enables participating districts to take advantage of large-volume buying through cooperative bids for teacher and office, art, physical education and janitorial supplies. These bids meet all legal requirements set forth in NYS General Municipal Laws 103 and 104(b).

Document Services provides duplicating, printing and bindery services for district newsletters, booklets, instructional materials, handbooks and many other related items.

Health and Safety provides technical assistance such as required staff safety trainings, AHERA support, emergency response planning, environmental complaint response, regulatory compliance and liaison with regulatory agencies.

Food Service Management provides management and coordination of the district's food service program.

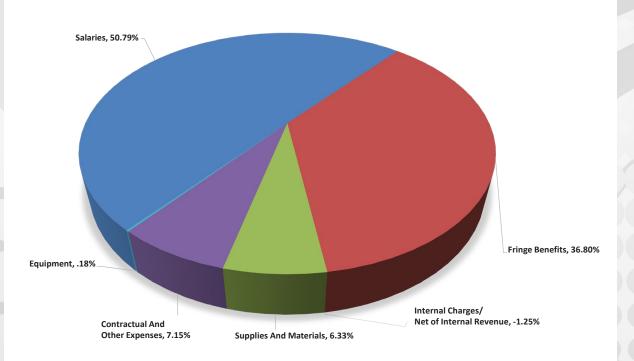
Communications assists districts in developing and implementing effective community relations and outreach programs. Services include the production of printed materials, social media management, website support, photography, video production media relations and crisis communication.

Teacher Registry provides school districts with substitute teachers to meet daily instructional needs along with attendance tracking services.
