## PALS: 12:1+1, 8:1+1 Learning Plan

Broome-Tioga BOCES is committed to providing all students with high quality, standards-based instruction. Instruction must be consistent and accessible to all students who attend a BOCES program. High quality instruction includes the targeted planning of lessons which engage students through a variety of modalities and assesses student learning on a continuous basis.

#### In-Person

- Teaching and learning will be consistent with a traditional in person model while maintaining all social distancing and safety protocols established by the Department of Health and NYS education department guidelines.
- Students will use Google Classroom or SeeSaw as their learning platform.
- Teachers will make initial contact with families via email or phone.

Students who are attending virtually or remotely will log in online at their regularly scheduled class time. Teachers will provide teaching and learning that meets the needs of all students.

Hybrid

- Students will use Google Classroom or SeeSaw as their learning platform.
- Traditional grading per the existing grading policy will be used.
- Teachers will make initial contact with families via email or phone.

#### Remote

- Students attending remotely will access their classroom via Google Classroom or SeeSaw.
- Families will primarily be in contact with their case manager.
- Related Services will be provided utilizing teletherapy or through coordinated materials being provided to the family.



#### **In-Person**

- A point of contact (case manager) will be identified for groups of students so that only one teacher will contact families (not multiple). The case manager will collaborate with the other teachers and maintain accurate information for families.
- Student attendance will be taken in person when on the BOCES campus.

- Student attendance will be taken by the teacher when a student logs in via Zoom and/or Google Classroom.
- Students and teachers will be required to actively participate. We encourage use of the video feature of Zoom during live instruction to facilitate engagement and feedback.

#### Remote

- A point of contact (case manager) will be identified for groups of students so that only one teacher will contact families (not multiple). The case manager will collaborate with the other teachers and maintain accurate information for families.
- Student attendance will be taken by the teacher when a student logs in via Google Classroom.
- Students and teachers will be required to use the video feature when on Zoom calls (no blank screens/photos).
- Best practices for remote engagement/assessment will be used.
- Instructional practices will align with the student's IEP goals/objectives as well as the NYS Alternate Assessment learning standards.
