The Position

The challenging dual role of the District Superintendent & CEO of Broome-Tioga BOCES involves working directly for the NYS Commissioner of Education and on behalf of the region's 16 component educational institutions. As liaison to the State Education Department, the District Superintendent may be called upon to interpret the rules and regulations of the New York State Board of Regents while assisting the districts in their implementation. This statewide role includes travel and special assignments in Albany and other sites that host professional meetings and consultations. As chief executive officer, the district superintendent is responsible for providing leadership to the schools within the supervisory district, and for administering, supervising, and evaluating the regional support services provided by the BOCES at the request of component districts and regional partners. The District Superintendent serves as the face of the BOCES in the region and a high degree of visibility is expected in this role. The District Superintendent is accountable to a seven-member Board of Education.

Terms of Employment

The successful candidate will be offered a three-year contract. Depending upon qualifications and experience, the compensation package will include a salary of up to the statutory cap, which will be \$208,000 for the 2022-23 school year. Residency in the supervisory district is strongly preferred.

The District Superintendent, in accordance with New York State Education Law, is appointed by the BOCES Board of Education with approval from the commissioner of education. The salary is derived from two sources: the local BOCES and the State Education Department. Provisions will be made for approval of business expenses, travel and participation in local, state, and national activities. By law, benefits are limited to those of "management confidential" level employees of the State Education Department. The combined salary for this position will be based on the candidate's educational background and professional experience.

The successful candidate would assume office on or before August 1, 2022.

Our Community

Broome-Delaware-Tioga BOCES is located in the eastern portion of the Southern Tier of New York state, an area with approximately 247,000 residents. BOCES' main campus is on the northern outskirts of the City of Binghamton near the junction of interstates 81, 88 and 86 (formerly state route 17). Greater Binghamton Regional Airport and a well-developed network of local highways add to the ease of access to the area.

Major employers in the area include Lockheed Martin System Integration, Endicott Interconnect Technologies, BAE Systems, United Health Services, Maines Food & Paper Service, NYSEG (Energy East) and many others.

The region's educational institutions include Binghamton University, SUNY Broome Community College, and New York State University Centers at nearby Cortland and Oneonta.

The area offers a wealth of entertainment venues and cultural activities as well as top-flight health care centers and an array of recreational and leisure time offerings.



Our BOCES

The Broome-Delaware-Tioga Board of Cooperative Educational Services was established in September 1954 and currently serves 15 central school districts and one common school district with a combined enrollment of approximately 36,000 students located within roughly 1,116 square miles. We take great pride in the fact that, overall, students in our region consistently score above the state average on assessments in all content areas.

As one of 12 Regional Information Centers strategically located around the state, we provide high-tech services to 50 school districts in three BOCES across a ten-county area.

Our facilities include a main campus, a Central Business Office, and four satellite education centers. On our main campus is the Leslie F. Distin Education Center, the Allen D. Buyck Instructional Support Center, and several smaller structures dedicated to maintenance, storage and receiving. In 2005, we completed a \$10.4 million capital building project on our main campus that added approximately 45,000 square-feet of new space and renovated another 30,000 square-feet of existing space.

Broome-Delaware-Tioga BOCES is one of 37 that make up the statewide BOCES network. Like all BOCES, we operate as an extension of our local school districts and the State Education Department, but we are unique in the types of programs and services we provide in response to the needs of our component school districts and community.

Our mission is Enriching Lives Through Education. Our primary goal is to do so in the most cost-effective, efficient manner possible. Our challenge is to equalize and maximize educational opportunity for every student by offering programs that meet the diverse needs of special education, occupational education, job training, career planning and college preparation.
