### Broome Delaware Tioga BOCES Program of Practical Nursing

- 1). On, April 30, 2020, Allen Buyck, CEO and District Superintendent of Broome-Delaware-Tioga BOCES signed the Funding Certification and Agreement for the Emergency Financial Aid Grants to Students under the Coronavirus Aid, Relief, and Economic Security (CARES) Act. This agreement solidified the school would disburse at least 50% to the students. This acknowledgement was submitted to the Department through the grants.gov website on 5/19/2020.
- 2). BT BOCES received notification the amount of \$47,082 had been deposited into the G5 account on 5/21/2020.
- 3). As of 6/12/2020 \$47,082 had been distributed to students.
- 4). The estimated total number of students at Broome Delaware Tioga BOCES Program of Practical Nursing eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act was 55.
- 5). The total number who have received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act is 55.
- 6). The PN program is smaller and it was decided all students were impacted by COVID-19. Administration decided to take the \$47,082 and divide it evenly amongst the 55 nursing students currently enrolled.
- 7). All students were mailed a letter of explanation for the check they received. The letter is copy and pasted below:

Dear Student,

Broome Delaware Tioga BOCES Program of Practical Nursing along with all other Higher Education Institutions in the country, have been awarded money through the CARES Act Grant funded by the Federal CARES Act stimulus package. BT BOCES School of Practical Nursing has been allocated \$94,163 under the CARES Act which became law on March 27, 2020. Half of this

allocation, \$47,082, must be used for providing emergency financial assistance to students. **The money is intended to be used for expenses related to the disruption of campus operations due to the coronavirus pandemic, such as food, housing, course materials, technology, health care, and childcare expenses.**

### **Qualifying Students**

Students who are currently enrolled in the Program of Practical Nursing at BT BOCES Adult Education will be awarded grant money through the CARES Act. Students must have satisfactory academic progress as well.

The Financial Aid Office has worked with Administration as to how the student relief grant money will be disbursed. Below is the amount each student is eligible for along with a check that matches the amount.
