Letter from our Area IV Supervisor: Douglas Ann Land

2010 has been a year of significant change for NYSSBA. The change from Republican to Democratic control in the Senate provided wonderful opportunities for several of our Governmental Relations staff who are now working as education advisors for the Senate Education Committee and Senator Oppenheimer. Although hampered by the dysfunction of the Senate in the first few months of the year, the staff, many of whom were newly hired, was able to make significant progress on both state and federal issues. Through their efforts and in collaboration with Senator Schumer, they influenced the mechanism of providing funding through both IDEA and Title I to maximize the greatest funding level and broadest distribution of funds without any monies being siphoned off for administrative expenses. Multiple efforts to instate midyear state aid cuts to education were successfully avoided, and efforts to pass on some pre-school special education costs were rejected by the Senate. Perhaps the most significant change is that the state now operates under executive order which requires that NYSSBA be consulted on every proposal that includes a new mandate on schools.

Based on comments and evaluations of last year's newly designed State Issues Conference, further modifications to this year's conference have been made. The event will be held at one hotel, the Crown Plaza from March 14-15. Starting late Sunday afternoon will allow attendees more travel time and an opportunity to check in at their leisure before the event begins Sunday afternoon. The presentation period of the conference will end after lunch Monday afternoon allowing the afternoon for meetings with representatives and the trip home, allowing those who cannot miss two days of work to participate.

If you have visited the NYSSBA Website lately, you've no doubt noticed some changes there as well. Our new two minute Mailbag educational videos have been quite popular. We now have 22 of them available, the last two of which are particularly timely: one describes what school districts can expect in changes in regulations from SED should the state qualify for the State Race to the Top funds; the second outlining the New Tier V benefits. This year also ushered in a highly popular series of Webinars which afford wonderful training for boards at a very reasonable cost. *Education in a Globalized World* on January 22 was very well received and is being followed on January 27th by *Teaching for the Future*. Watch for announcements of upcoming Webinars – as several board members can watch at once, many schools are arranging to have them broadcast in a board conference room where the board can hold a discussion following the presentation. Once enrolled for a Webinar, if the timing is not convenient, it can be downloaded and watched at any time. For those of you who prefer to communicate on Facebook, NYSSBA is now offering a Facebook Fan Page as well. Perhaps the latest news in the communications area is our new video, *Be the Change for Kids* which was officially launched on January 11th. The video highlights the effects of diminished funding for schools, and explores what we as schools, legislators and communities can do to support educational opportunities for our children. Many of our Central New York School Boards Associations are showing "*Be the Change*" to open their Legislative Breakfasts and to spark discussion with legislators on cost saving measures we have already taken and the possibility of increased staff reductions, class size increases and program cuts in the immediate future.

The year 2010 promises to be a challenging one for those of us in primary and secondary education. Our goal at NYSSBA is to assist all of our schools in successfully meeting these challenges. At our board retreat in October, we set forth two new objectives: 1)NYSSBA will empower school boards to overcome the effects of the financial crisis; 2) NYSSBA will inspire school boards to embrace methodologies that increase success for each student in the 21st Century. We do intend to be successful in meeting both of these objectives and look forward to working with all of our school boards in meeting these two challenges.
