New Visions Law & Government Academy

Our program

The New Visions Law and Government Academy is an engaging and challenging program for students who are curious about careers in the law and public service. This program is for students who are ready for independence and responsibility outside of the traditional classroom and want to experience how social, political, and legal systems work together. Students learn from professionals such as lawyers, judges and elected officials. Students learn about the purpose of government and the election process through real-life observation, working alongside professionals, independent research, class debates and discussions, authentic projects, and attending special events. Students learn about the law through meeting with attorneys and judges, exploring local and Supreme Court cases, observing in court, and researching charges in the NYS Penal Code.

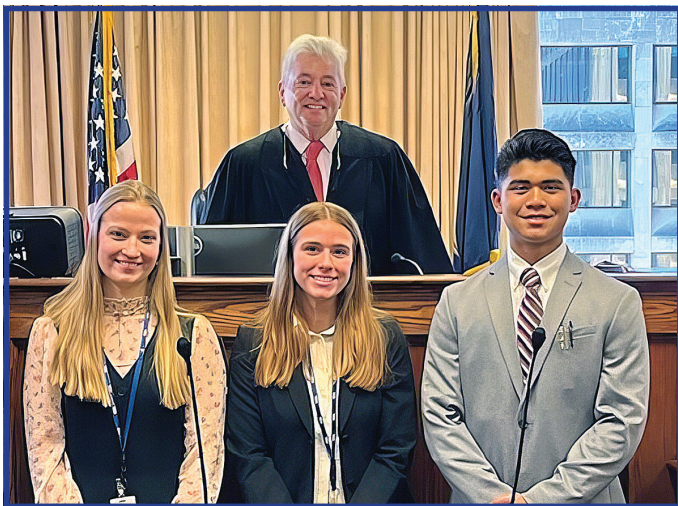
