The Broome-Tioga School Boards Association Annual Business Meeting/ Meet the Candidates Evening was held on October 18th at Broome-Tioga BOCES, Les Distin Education Center. The evening began with registration and light refreshments at 6:30 p.m.



The first order of business was to elect this year's BT-SBA President and Vice President. Congratulations to Dan Griffith of Union-Endicott Central School District and Michon Stuart of Vestal Central School District who will serve a second term as President and Vice President respectively.

The 2009-2010 BT-SBA financials were approved at the meeting and a copy of that report is included in this DOT-DASH.

Joining the event were local politicians seeking office in the November election. We were pleased to host Assemblywoman Donna Lupardo and her opponent Art Garrison seeking a position in the 126th Assembly District, and John Orzel who is seeking a seat in the 52nd Senatorial District.
